If a municipality changes any part of chapter of its comprehensive plan, it must submit the comprehensive plan amendment to the Metropolitan Council for review. Municipalities amend their comprehensive plans for various reasons, including: Changes resulting from neighborhood or small area planning activities, land use changes to allow a proposed development, proposed forecast changes or proposed MUSA expansions, text changes to revise a policy or land use category, routine updates to incorporate new information or update a public facilities element.
